Explanation of Estimate:

LB 521 is to change and eliminate provisions relating to automated vehicles. The bill adds a provision under the definition of driverless-capable vehicle to require that a conventional human driver is physically present in the vehicle and able to take control of the vehicle if needed. It adds a provision that the automated vehicle safely negotiate around school crossing zones as well as railroad crossings.

No fiscal impact is anticipated to the Dept. of Transportation.
