This bill would change human trafficking civil damage provisions. It allows a court to increase the award of damages to a plaintiff who prevails in a civil action brought pursuant to the Human Trafficking Victims Civil Remedy Act to an amount that bears a reasonable relation to the actual damages which have been sustained. Actual damages may include costs of medical and psychological treatment, transportation, temporary housing, child care, property damage, income loss and other damages a trafficking victim may incur.

It appears that this bill will not have any significant fiscal impact to the state or political subdivisions.

The Supreme Court estimates a minimal fiscal impact from the provisions of this bill.
