Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would require the Department of Correctional Services (DCS) to provide the Public Counsel and the Inspector General with access to information submitted into their criminal information data base. It does not require DCS to provide access to information submitted into the data base by local, state, and federal law enforcement agencies.

DCS states that this bill would require them to develop a system for individuals to be granted different access into their criminal information data base. DCS would need to hire a contractor to perform this task, and they note that the estimated completion date would be in two years. They estimate a cost of \$31,250 to complete this project, plus an additional \$9,777 in fees for three software licenses at \$3,259 per license. The total cost is estimated to be \$41,027 in FY21.

The Legislative Fiscal Office (LFO) fiscal analyst has no reason to disagree with this estimated cost. However, the agency should be able to handle this estimated cost within their current appropriation.
