This bill would provide for enhanced penalties and a civil action for crimes committed because of a victim's gender identity or association with a person of a certain gender identity and include strangulation in the offenses eligible for enhancement.

This bill could potentially increase the number of persons sentenced to prison because it expands on the current provisions of law. If this bill results in additional persons sentenced to prison compared to current law, then this could result in additional costs to the Department of Correctional Services (DCS).

DCS estimates that this bill will have an indeterminate fiscal impact.

The Supreme Court estimates a minimal fiscal impact.

The Board of Parole estimates no significant fiscal impact from this bill.

The Crime Commission estimates no fiscal impact from this bill.
