This bill would change a penalty for controlled substance possession as prescribed. The bill provides that if the controlled substance is an amount constituting only residue, a person is guilty of a Class I misdemeanor, and if the controlled substance is an amount constituting more than residue, a person is guilty of a Class IV felony.

The Supreme Court estimates a minimal fiscal impact from the provisions of this bill.

The Board of Parole estimates no significant impact from this bill.

The Department of Correctional Services states that the fiscal impact of this bill is indeterminable.
