Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 718 amends the Election Act to require the election commissioner in a county with more than 100,000 inhabitants to provide additional office hours during which ballots for early voting may be picked up or returned. The additional hours shall include at least four hours on each of the two Saturdays preceding the day of the election and at least five hours during each week of such two-week period in additional to normal business hours on business days.

The Lancaster County Election Commissioner estimates the additional office hours will cost \$2,416 in fiscal year 2019-20 and \$3,608 in fiscal year 2020-21. There is no basis to disagree with these estimates.
