Explanation of Estimate:

LB 800 adds the following language to the applicability of the state building code for all state agencies, state constitutional offices, state administrative departments, and state boards and commissions, the University of Nebraska, and Nebraska state colleges:

"The state building code shall be the legally applicable code in all buildings and structures owned by the state or any state agency regardless of whether the state, state agency, or applicable county, city, or village has provided for the administration or enforcement of the state building code."

Similar language is also included in LB 800 for Nebraska counties, cities, or villages.

Under current state law § 71-6405, all state agencies are required to follow the state building code. The proposed revisions would require state agencies and local governments to conform to the state building code whether or not the state agency or local government has provided for the administration or enforcement of the state building code.

LB 800 has no fiscal impact on DAS since state agencies must currently comply with the state building code.
