Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 987 amends the Revenue Act of 1967 to impose sales and use tax on the gross income received for dating and escort services. The bill specifies, for transactions occurring after October 1, 2020, the proceeds from sales and use taxes collected on dating and escort services will be credited to the Human Trafficking Victim Assistance Fund.

The bill is operative October 1, 2020.

Revenue:

The Department of Revenue estimates the additional sales and use tax revenue collected is indeterminable due to unavailability of data. We agree. Data on the gross income received from dating and escort services in Nebraska is unavailable, and therefore, the total amount of sales tax revenue to be collected and credited to the Cash Fund is indeterminable.

The bill requires the entirety of the proceeds from the sales and use tax imposed on dating and escort services to be credited to the Human Trafficking Victim Assistance Fund, and as such, the portion of the proceeds directed to the State Highway Capital Improvement Fund and Highway Allocation Fund under current law will be transferred from the General Fund, resulting in a General Fund revenue loss.

Expenditures:

The department estimates a one-time cost of \$22,956 to OCIO for mainframe and web development costs. The Crime Commission does not estimate any additional costs to implement the bill. There is no basis to disagree with these estimates.

LB 987 adds gross income received from dating and escort services to the definition of gross receipts in Neb. Rev. Stat. §77-2701.16. For transactions occurring on or after October 1, 2020, all proceeds from the sales and use tax derived from the sale of dating and escort services is credited to the Human Trafficking Victim Assistance Fund. LB 987 becomes operative on October 1, 2020.

The revenue gains or losses due to LB 987 are undeterminable due to data unavailability on dating and escort services.

LB 987 requires a one-time operating cost of \$22,956 paid to the OCIO for mainframe development costs and web development cost. The Department of Revenue can implement this bill with existing staff.
