Explanation of Estimate:

There is no fiscal impact for this legislation. LB1086 requires the Secretary of State to provide credentials for each poll watcher from a national or international election monitoring organization. In order to ensure the authenticity of such credentials, the Secretary of State would print photo identification cards including the required information. The Licensing Division of our office already has a card printer that could be utilized by the Election Division for this purpose. LB1086 also requires the Secretary of State to notify the county representatives of the poll watchers, including providing a list of required information. We expect that this requirement could be met within existing staff resources.
