LB 850 requires the Secretary of State to submit to the United States Secretary of the Interior a written request to approve and authorize the placing of a monument within the boundaries of the Fort Donelson National Battlefield commemorating the First Regiment Nebraska Volunteer Infantry.

Section 3 creates the First Regiment Nebraska Volunteer Infantry at Fort Donelson Committee. The Committee is charged with selecting a designer, sculptor, and mason to create a monument and approve the design of the monument

Section 4 requires the Committee shall be funded by gifts, grants, bequests, donations and other privately donated funds and administered by a private foundation. No General Funds of the state shall be expended for the purpose of the Act.
