Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 885 would amend a section of law governing the Civic and Community Center Financing Act. Under LB 885, grant applications for projects relating to historic buildings or districts would be required to include a notification of approval from the State Historic Preservation Officer. It is estimated that there would be no fiscal impact to the Department of Economic Development, the agency that administers the grant program. There may be additional costs incurred by the State Historical Society to carry out grant application project reviews. Any costs would depend upon a future requests developed and submitted by political subdivisions, and cannot be estimated at this time.

Explanation of Estimate:

LB885 changes the order of the required steps in the application process for grants under the Civic and Community Center Financing Act. Currently, applications for civic and community center grants for assistance in the preservation, restoration, conversion, rehabilitation, or reuse of a historic building or district are filed with the Department of Economic Development (DED) along with applications that do not affect these buildings or areas. DED reviews the applications and sends any that affect historic buildings or districts to the State Historic Preservation Officer (SHPO) to determine whether it conforms to the US Secretary of the Interior’s Standards for the Treatment of Historic Properties. If the application does not conform to the standards, DED cannot award a grant.

LB885 changes the order of the SHPO review in the application procedure. Municipalities applying under the act for projects that affect historic buildings or districts will be required to send the proposed project to SHPO for a notice of approval before application to DED.

LB885 will result in no fiscal impact for DED.
