**Explanation of Estimate:**

LB 1006 requires a garnishee to answer written interrogatories, to be attached to a court summons, within thirty days from the date of the service upon the state. The summons sets forth the amount due on the judgment, interest, and costs. Current statute requires an answer to written interrogatories within ten days from the date of service upon the state.

LB 1006 does not change the number of garnishments the state expects to receive or respond to. It does allow greater flexibility with the extended response time.

There is no fiscal impact.
