LB976 expands the definition of handicapped or disabled person to include any individual with a severe neurological impairment as it relates to the Department of Motor Vehicles (DMV) duty to issue a Handicapped or Disabled Person plate or parking permit. The plate or parking permits are provided at no additional charge to individuals.

With a process already being in place to issue such permits, any fiscal impact should be able to be accommodated within the DMV existing appropriation.

The DMV has provided a fiscal note (see attached) indicating minimal programming is necessary but that the cost can be absorbed within their existing appropriation.
