LB553 establishes the Bed Bug Detection and Treatment Act. The provisions of the bill establish definitions as well as responsibilities and requirements of tenants and landlords. Further, the bill denotes those situations where liability for actual damages, or a ruling pertaining to access to a unit, may pursued in a court of competent jurisdiction.

The Department of Agriculture and Department of Health and Human Services have indicated a fiscal impact is absent.

The Supreme Court has indicated minimal fiscal impact is present to provide education to judges and court staff.

The City of Omaha was unable to provide a fiscal note.
