Explanation of Estimate:

LB 212 indicates that a public record request made by a member of the Legislature must be fulfilled within 15 business days and without a fee assessed. Members of the Legislature typically go through the Department of Health and Human Services' (DHHS) Office of Legislative Services to get their record requests fulfilled. The primary concern regarding this bill would be the 15-day requirement, as some requests can be voluminous and near impossible to complete in that timeframe without stopping other vital duties of the agency. DHHS receives a high volume of public records requests, some of which are extremely voluminous. Current staff would be able to absorb the duties for requests that will be from members of the legislature causing no fiscal impact to the department.
