LB126 amends NRS 60-6,219 to be inclusive of the requirement that every motor vehicle when operating its windshield wipers continuously due to rain, sleet, snow, or other moisture, shall have in use its headlights and taillights. An individual who violates this requirement will be guilty of a Class III misdemeanor.

Any fiscal impact is not able to be discerned due the inability to predict how many citations would be issued pursuant to violation of the new requirement and discretion provided for in adjudication.

The Crime Commission, Supreme Court, and State Patrol have indicated no fiscal impact is present.
