LB 21 eliminates the provision that the Department of Insurance organization be required to transmit copies of an application for insurance of a certificate of authority for health maintenance organizations who are solely providing health care benefits known as Medicare Parts C and D to the Department of Health and Human Services (DHHS). The federal government who issues the certificates of authority for these organizations is responsible for endorsement of these providers causing this to be a redundant task for the Department of Insurance.

For all other health maintenance organizations, the Department of Insurance is required to submit the copies of application for issuance of a certificate of authority to DHHS to verify compliance with sections 44-32,126 to 44-32,128 with respect to health care services to be furnished.

LB 21 has no fiscal impact.
