If the Attorney General determines that the proposed measure contains more than one subject, the Attorney General shall issue a written opinion suggesting changes to divide such proposed measure into separate and distinct subjects within the proposed measure. Such opinion shall be completed within ten days after receipt from the Secretary of State.
