**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 285 changes provisions regarding voter registration lists.

Section 1 exempts the Secretary of State from disclosing as public record, any information received from a nongovernmental entity of which the Secretary of State is a member, whose purpose is to share and exchange information in order to improve the accuracy and efficiency of voter registration systems. The Secretary of State may provide such information to the election commissioners and county clerks to conduct voter registration list maintenance activities.

Section 4 changes the start date for candidate filing forms from December 1 to January 5, prior to the date of the primary election.

The Secretary of State estimates no fiscal impact. This appears to be reasonable.
