Any costs incurred by an authority for review by an outside consultant shall be included in the application fee, and be based on objectively reasonable costs. Such fees shall not exceed the usual and customary fee charged for the services provided.

Authority is defined as; "(A)ny county, city, or village whose authorization is necessary prior to the deployment of a wireless facility."
