Explanation of Estimate:

LB479 amends the Convention Center Facility Financing Assistance Act. For cities of the metropolitan class, the bill adds two members to the committee designated to represent areas with a high concentration of poverty: 1) An additional resident member and 2) the member of the legislature whose district includes a majority of the census tracts of persons living below the poverty line.

LB479 has no fiscal impact on the DED.
