LB 1005 amends statute 77-1835, which relates to providing notice for the purchase of certain real property. Statute 77-1835 requires the publishing of notice for three weeks for individuals that cannot be found to be served notice.

LB 1005 would require such purchasers to mail notice to the name on the title of the real property being purchased within 5 days of publishing notice in the newspaper. This notice must also be filed and recorded with the county treasurer's office.

It is not expected there will be any fiscal impact due to LB 1005.

The Nebraska Association of County Officials estimates no fiscal impact. The Lancaster County Treasurer estimates no fiscal impact.
