Explanation of Estimate:

LB839 repeals the Licensing of Truth and Deception Examiners Act, which would result in the loss of revenue from the truth and deception examiner licensing fees. Based on historic revenue, this cash fund loss is estimated to be \$1,250 per year. Historic data specific to truth and deception examiner licensing expenditures is not available and therefore we are not able to estimate the impact to expenditures. We anticipate that the impact, if any, will not be significant
