LB 1263 changes provisions of the Election Act.

Section 2 of LB 1263 adds a new section to the Election Act to allow election commissioners or county clerks to maintain a secure ballot drop-box for voters to deposit completed ballots. The election commissioner or county clerk shall notify the Secretary of State of each drop-box location no later than 42 days prior to any statewide primary or general election. Drop-boxes shall be open no later than the sixth Friday prior to any statewide primary or general election and no later than the fourth Friday prior to a special election. Election commissioners or county clerks shall collect deposited ballots at least once each business day.

The Secretary of State may adopt and promulgate rules and regulations to carry out LB 1263's provisions.
