Explanation of Estimate:

LB106 creates the offense of digital grooming of a vulnerable adult and prohibits using an electronic communication device or social media to engage in certain conduct with vulnerable adults. The bill could increase the number of persons in prison. The specific amount of impact is indeterminable.

As of December 2022, the average daily prison population (ADP) was 147% of design capacity. The FY22 per diem cost was \$28.38 for each inmate, or \$10,358.63 per year.
