LB 220 changes provisions relating to notices required to be given to crime victims and the Board of Pardons’ powers and duties. The bill states that upon request of the victim and at the time of conviction of the offender, the county attorney of the jurisdiction in which a person is convicted of a felony will forward to the Board of Parole, the Department of Correctional Services, county corrections agency, or Department of Health and Human Services, the name and address of any victim.

The agencies should include the name in the file of the convicted person, but the name will not be part of the public record of any parole hearings of the convicted person.
