LB 439 appropriates funds from the General Fund for fiscal year 2023-2024 and 2024-2025 to the Department of Correctional Services (NDCS). The purpose of the funds is for NDCS to implement a pilot project for domestic violence treatment programming for individuals committed to NDCS. NDCS will contract with an academic institution located within the State of Nebraska to design and study the pilot project.

Expenditures:

NDCS would contract with the Nebraska Center for Justice Research (NCJR) to conduct a two-year pilot project. The agency states that the total cost would be \$350,000.
