LB188 amends §79-8,145 to allow the Commissioner of Education to change the provisions of getting a Nebraska teaching certificate to grant a temporary certificate to eligible veterans to teach full-time if they meet the following criteria:

- Has at least forty-eight months of military service
- Has a minimum of sixty college credits with a minimum cumulative GPA of 2.5 on a four-point scale or the equivalent
- Has passed an appropriate subject area examination as designated by the Nebraska State Board of Education

Applicants that have been issued a temporary certificate will be assigned a teacher mentor for a minimum of two school years. Teacher mentors will already hold a valid Nebraska teaching certificate and have at least three years of teaching experience. The temporary certificates are not renewable and are valid for no more than five years. During those five years, the applicant must obtain a teaching certificate through the Nebraska Department of Education (NDE).
