**Explanation of Estimate:** 

LB137 provides for a penalty enhancement for a controlled substances violation resulting in serious bodily injury or death. The bill could increase the length of stay of persons in prison, thereby increasing the overall prison population. The specific amount of impact is indeterminable.

As of December 2022, the average daily prison population (ADP) was 147% of design capacity. The FY22 per diem cost was \$28.38 for each inmate, or \$10,358.63 per year.
