LB 236 amends provisions relating to problem-solving court judicial officers and creates a problem-solving court pilot project. The Supreme Court may appoint problem-solving court judicial officers as needed to serve on a full- time or part -time basis in all problem-solving courts and may assign such judicial officers to such locations as the Supreme Court shall determine.

On or before January 1, 2024, the Supreme Court shall create a pilot project utilizing one or more problem-solving court judicial officers to oversee problem-solving courts selected by the Supreme Court. The purpose of the pilot project is to determine if such officers can effectively provide additional judicial resources for problem-solving courts.

Expenditures:

LB 236 would require the Supreme Court to create a problem-solving court and a pilot project to evaluate the effectiveness of such positions. The Estimated impact would cost \$125,675 in FY 24 and \$264,650 in FY 25. The estimates are based on adding one officer position and a courtroom clerk.

There is no basis to disagree with the estimates.
