Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB428 would require the Nebraska Emergency Management Agency (NEMA) to provide up to half of the matching requirement needed by a political subdivision seeking grant funds, from the federal Hazard Mitigation Grant program. This bill authorizes NEMA to adopt the necessary rules and regulations to carry out LB428.

The Military Department has indicated LB428 is estimated to cost \$995,937 annually in General Funds for State Aid. For FY2023-24 and FY2024-25, NEMA deems these expenditures could be absorbed by their current appropriation.

There is no basis to disagree with NEMA.

The \$995,937 expenditure figure above represents the annual average of what the State share would have been if the State had participated in the non-federal share of the Hazard Mitigation Grant Program (HMGP) and the Building Resilient Infrastructure and Communities (BRIC) grant. In all declared disaster since 2011, the 100% obligated total of all Hazard Mitigation projects has been \$92,878,499. In almost all of those events, the federal share was 75% of the total cost.

Sufficient internal funds exist that the annual average cost of \$995,937 could be absorbed for the next several years, with internal policy changes.
