Under the bill, on or after January 31, 2024, a wholesaler would be granted the right to purchase and sell a brand or brands of beer sold by a small producer through a small producer contract. A copy of a small producer contract would be filed with the Nebraska Liquor Control Commission (Commission) by the wholesaler within 10 days after execution of such contract. The bill also adds definitions of the terms small producer and small producer contract and harmonizes provisions.

The Commission estimates no fiscal impact as a result of this bill. There is no basis to disagree with this estimate.
