LB472 amends 60-6,273 to state that evidence that a person was not wearing an occupant protection system or a three-point safety belt system at the time of their injury, is admissible in civil proceedings with regard to the issue of liability or proximate cause, and concerning mitigation of damages.

The Nebraska Supreme Court, Nebraska State Patrol, Nebraska Department of Transportation, and the Nebraska Department of Motor Vehicles all have indicated no fiscal impact from LB472.

There is no basis to disagree with either the Nebraska Supreme Court, Nebraska State Patrol, Nebraska Department of Transportation, nor the Nebraska Department of Motor Vehicles' estimations of no fiscal impact.
