Explanation of Estimate:

LB 619 prohibits assault on a public transportation driver and clarifies provisions relating to assault on officers, emergency responders, certain employees, and health care professionals. The bill could increase the number of persons in prison and the length of stay of persons in prison. The specific amount of impact is indeterminable.

As of December 2022, the average daily prison population (ADP) was 147% of design capacity. The FY22 per diem cost was \$28.38 for each inmate, or \$10,358.63 per year.

LB 619 proposes updates to the penalty classifications Nebraska Criminal code in regards to the offense of assault if such a person intentionally or knowingly causes bodily injury to a: (a) public safety officer while such officer is engaged in the performance of the officer’s official duties, (b) health care professional while such professional is on duty at a hospital or health clinic, or (c) public transportation driver while such driver is engaged in the performance of such driver’s official duties.

If enacted, no fiscal impact is anticipated to the Department.
