Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 934 changes provisions of the Consumer Protection Act by allowing the Attorney General to bring claims under the Act for trial by jury. When the Attorney General has reason to believe there are violations of the Act, he or she may:

1. Require persons to file a statement or report in writing under oath as to all facts and circumstances related to the sale of property or services;
2. Examine under oath any person in connection with the sale of property or services;
3. Examine any property or sample record, book, document, account or paper;
4. Pursuant to an order of any district court, impound any record, book, document, account, paper or sample of property that is material to such violation; and,
5. Pursuant to an order of any district court, temporarily freeze any bank account or other financial account or impound any money or property connected with any such violation until the completion of all proceedings undertaken under the Act.

Similar powers are also provided to the Attorney General under the Uniform Deceptive Trade Practices Act.

The Attorney General estimates no fiscal impact. This appears to be reasonable.
