LB1267 is the Uniform Public Expression Protection Act.

Section 2 defines terms in the bill.

Section 3 outlines the procedures and timeframes for filing a special motion for expedited relief to dismiss a cause of action, or part of it, under the Uniform Public Expression Protection Act. It specifies that such a motion can be filed not later than sixty days after a party is served with a complaint or other pleading asserting a cause of action covered by the Act.

Section 4 provides guidelines on the handling of special motions filed under the Uniform Public Expression Protection Act. It mandates that the court rule on these motions within a specified timeframe.

The Supreme Court would have minimal fiscal impact from LB1267.
