LB 1185 changes provisions relating to obstruction of a peace officer. The bill allows individuals to record peace officers with video or audio while they are performing their duties, provided the person recording maintains a distance of at least ten feet from the officer, unless the officer is directly interacting with the person recording.

The Supreme Court would have minimal fiscal impact to provide judicial education.
