LB 1334 aims to amend sections related to criminal procedure, focusing on the revocation of probation and the waiver of probation fees. The bill changes the financial obligations of individuals on probation, including the establishment and waiver of administrative enrollment and monthly probation programming fees, and outlines conditions under which these fees can be waived due to indigence or hardship.

The Supreme Court is expected to experience minimal fiscal impact. While the agency may generate revenue from probation fees, the exact amount remains indeterminable at this time.
