The Supreme Count indicates the provisions of the bill may reduce costs to the agency by the number of court cases involving guardianships and may increase costs to county courts by requiring court appointed representation in certain cases. The fiscal impact is indeterminable at this time.

In these instances, the Department will absorb the costs of any additional hours needed to document the findings related to the individuals lack of capacity. These findings may include the opinion of the cause, nature, extent, and probable duration.

DHHS will also absorb the costs of any additional hours needed to document the advanced healthcare directives made by a person's default surrogate, who will make healthcare decisions for them, if the person does not have a guardian or agent.
