The bill would remove the requirement that the application for a duplicate certificate of title for motor vehicles that have lost or mutilated titles, be both signed and sworn to by the applicant or authorized person.

The Nebraska Department of Motor Vehicles (DMV) and the Lancaster County Treasurer have both indicated no fiscal impact as a result of this bill.
