Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB398 proposes annual revisions to match state law to federal law references and regulations for the Nebraska Department of Motor Vehicles (DMV) and the Nebraska State Patrol (NSP). This harmonizing with federal statutory language, along with deletion of obsolete language, must be done on an annual basis to avoid incompatibility and remain current with federal regulations. The bill changes civil penalties. Additionally, this bill updates commercial driver's license or CLP-commercial learner's permit release information, self-certifications, and medical exams/waiver language in statute. This bill contains an emergency clause.

The Nebraska Department of Motor Vehicles, the Nebraska Public Service Commission, and the Nebraska Supreme Court have all indicated no fiscal impact to their agencies.

There is no basis to disagree with these estimates.
