LB120 would amend Nebraska §60-484.02 to allow the Nebraska Department of Motor Vehicles (DMV) the ability to release a digital image from a motor vehicle operator's license to the Nebraska State Patrol (NSP). If the NSP has deemed the individual missing and cannot be located, for the purpose of posting the digital image on to the Missing Persons Clearinghouse website.

Both the Nebraska Department of Motor Vehicles (DMV) and the Nebraska State Patrol (NSP) have indicated no fiscal impact.

There is no basis to disagree with these agency estimations.
