LB 686 changes provisions relating to firearms.

Section 1 defines the following terms for purposes of this section:

- Ammunition;
- Assign or assignment;
- Covered entity;
- Firearm;
- Firearm retailer;
- Merchant category code;
- Payment card;
- Payment card network; and
- Payment card transaction

Under LB 686, no government entity, official, or agent or employee of a government entity or official shall knowingly keep or cause to be kept any list, record, or registry of privately owned firearms or the owners of firearms, except for those records kept during the regular course of a criminal investigation, prosecution, or as otherwise required by law.

The Attorney General shall investigate reasonable allegations that a person or entity, including a government entity, has violated this section. Upon finding a violation, the Attorney General shall issue a written notice to the person or entity. Such person or entity shall cease the violation within thirty business days after receiving the written notice. Failure to cease the violation shall result in the Attorney General filing an action to seek an injunction. Further actions are allowed for in the case of continuing the violation and failure to comply.

The Attorney General estimates no fiscal impact.
