- eliminates the Nebraska Potato Development Committee, transfers its duties to the Department of Agriculture, and clarifies definitions for the Nebraska Potato Inspection Act.
- eliminates language regarding the Board of Advanced Practice Registered Nurses.
- eliminates language regarding Board of Alcohol and Drug Counseling.
- eliminates language regarding the Board of Examiners of County Highway and City Street Superintendents
- eliminates language regarding the Foster Care Reimbursement Rate Committee and the Bridge to Independence Advisory Committee.
- eliminates language regarding the State Advisory Committee on Substance Abuse Services.
- eliminates language regarding the Advisory Council on Public Water Supply
- eliminates language regarding the Breast and Cervical Cancer Advisory Committee
- eliminates language regarding the Vacant Building and Excess Land Committee.
- eliminates language regarding the State comprehensive Capital Facilities Planning Committee
- eliminates language regarding the technical panel created for the Information Technology Infrastructure Act
- eliminates language regarding the task force created for the purpose of investigating and studying human trafficking
- eliminates language regarding the State Emergency Response Commission
- allows gubernatorial appointees to act as recess appointees on the Board of Public Roads Classifications and Standards, if they are appointed outside of the legislative session.
- changes some duties from DHHS regarding the Critical Incident Stress Management Council and removes the State Patrol and State Fire Marshal from the Critical Incident Stress Management Council.

Explanation of Estimate:

LB 905 proposes to clean up the language of various statutes related to a past bill (LB 346, 108th Leg., 1st Session) that goes into effect July 1, 2026, and eliminated several boards and commissions.

Duties of the Vacant Building & Excess Land Commission were absorbed by DAS in LB 346. LB 905 provides that, upon review of the State Building Administrator, the Director of Administrative Services (DAS) has the responsibility to declare any building or land vacant or excess, as well as the appropriate action to be taken. Further, the Director of Administrative Services is given the responsibility of certifying the approval of a utility easement on state-owned land submitted by a state agency.

LB 905 further eliminates any reference to a State Comprehensive Capital Facilities Planning Committee to clarify that the DAS State Building Division is responsible for the comprehensive planning guidelines and process of project prioritization.

The bill also eliminates any reference to a "technical panel" that is part of the Nebraska Information Technology Commission, and that is eliminated effective July 1, 2026, per LB 346.

The bill has no fiscal impact to the Department of Administrative Services.

Explanation of Estimate:

Under LB905, any individual serving on the Board of Examiners for County Highway and City Street Superintendent (BEX) as of June 30, 2026, would be eligible to join the Board of Public Roads Classifications and Standards prior to the termination of the board on July 1, 2026. Standard qualification requirements of Neb. Rev. Stat §39-2106 (2) through (6) would not apply to BEX members joining the Board of Public Roads Classifications and Standards.

If enacted, LB905, would allow a Board of Public Roads Classifications and Standards member appointed by the Governor to take office temporarily until the next meeting of the Legislature. The bill gives the board approval to meet as necessary to carry out the duties under the County Highway and City Street Superintendents Act and sections 39-2101 to 39-2125.

LB905 provides approval for expense incurred by the Board of Public Roads Classifications and Standards pursuant to the County Highway and City Streets Superintendents Act and sections of 39-2101 to 39-2125 to be paid by the Roads Operations Cash Fund.

No fiscal impact to NDOT is anticipated.
