LB1202 modifies and modernizes Nebraska statutes for the process of obtaining ignition interlock devices in Nebraska via the Nebraska Department of Motor Vehicles (DMV), the Nebraska Board of Pardons, or a court. This bill refines the penalties for individuals who operate motor vehicles in violation of their ignition interlock order. Additionally, LB1202 details how ignition interlock service facilities should provide notification of detected tampering, disabling, or bypassing of the ignition interlock device.

This bill would become effective three calendar months after the adjournment of the Legislature.

The DMV and the Nebraska Board of Parole have both indicated no fiscal impact. The Supreme Court indicates minimal fiscal impact.

There is no basis to disagree with these estimations.
