LB 881 would require local law enforcement agencies and jails to provide public notice and obtain approval from their governing body at a regular public meeting before agreeing to help enforce federal immigration law. The Nebraska State Patrol would be required to provide notice and obtain approval from the Nebraska Commission on Law Enforcement and Criminal Justice through the same public process. Agreements not approved through this process are void, and existing agreements must be reapproved by October 15, 2026, or they terminate on December 1, 2026.

There is no fiscal impact.
