LB 951 would change the district boundaries in municipal elections to include extraterritorial zoning jurisdiction.

The Secretary of State and Lancaster County Election Commission estimate no fiscal impact.

Douglas County Election Commission indicates a negative fiscal impact. Douglas County would incur costs approximately totaling \$240,000 to redraw precinct boundaries as well as the costs of postage and printing of postcards to voters in new polling areas. The county also anticipates an increase in proofing and ballot testing for each election due to the split precincts causing more ballot faces. The additional costs are unknown.
