It allows all public bodies to hold virtual meetings at least half of the time and outlines requirements for those meetings. It allows certain public bodies to hold virtual meetings more than half the time.

Some agencies may experience some savings if they change to virtual meetings. These savings may be realized in the next budget request.

Explanation of Estimate:

By allowing greater flexibility in using virtual conferencing means for the boards and commissions supported by the Nebraska State Historical Society, it is estimated that costs related to mileage and per diem would be reduced. However, it is difficult to estimate what those savings would be given variable frequency of meetings for each board and commission. For example, for the Nebraska State Historical Society Board of Trustees over the past three fiscal years the society spent \$10,958 in lodging expenses and another \$4,148 in mileage expenses, or an average of approximately \$5000 per year. Assuming one of four meetings was held in person, a maximum cost savings of approximately \$3776 could be realized, assuming costs remain static.
