LB 909 creates a new felony offense for sexual abuse by a law enforcement officer involving a minor who is at least 16 but under 19.

It establishes three degrees of the offense: first degree when the conduct involves sexual penetration, second degree when it involves sexual contact, and third degree when there is a pattern or scheme used to subject the minor to sexual penetration or sexual contact. The bill also specifies that the minor's consent is not a defense.

The Supreme Court states that minimal fiscal impact is anticipated for judicial education and that no additional resources are required.
