The bill removes the option of a health care facility to waive participation in the HIE and modifies the member composition of the Health Information Technology Board. The Department of Health and Human Services indicates potential future costs to support modernization efforts if there is no HIE waiver. The fiscal impact is indeterminable.

Explanation of Estimate:

LB950 strikes the ability of a health care facility to apply for a waiver to not participate in the Health Information Exchange (HIE), which could result in a downstream fiscal impact to the Department of Health and Human Services (DHHS). DHHS, and associated federal financial participation, is the primary funding source for the HIE. This could result in additional facilities connecting to the HIE who do not have modern medical record systems and could result in the HIE vendor seeking additional funding from DHHS to conduct connections between the facilities and HIE.
